## AWWA Annual Conference Meeting Summary

The AWWA Annual Conference is in Dallas, Texas, June 10-14, 2012. The Partnership for Safe Water had two meetings and its annual awards luncheon.

**Steering Committee meeting summary:** The meeting agenda included a discussion of the revised program budget and personnel changes of Partnership staff at AWWA, draft operating agreement between AWWA and the Partnership, and the development status of the new distribution system optimization program.

- Bill Lauer announced his retirement effective September 1, 2012.
- The Steering Committee passed a resolution to be involved in the hiring of a new Program Manager.
- Robert Cheng, Chair, reported on the AWWA/Partnership operating agreement. The revisions from the Steering Committee may need another round of review before agreement can be reached. All parties are confident that agreement is close at hand.
- The 2012 and proposed 2013 budgets were discussed. The 2012 budget will be tight so PEAC training cannot be conducted this year. Training should be back on the schedule for 2013.
- The Steering Committee passed changes to the annual reporting requirements. These included addition of the requirement for the new Presidents Award.
- EPA has proposed the possible addition of a new program element on water system security. The Partnership is collaborating with EPA to determine if this would be a good fit to provide self-assessment tools to help utilities in this area.

**PEAC-Treatment Committee:** Members will discuss potential training, status of current report reviews, and process for the new Presidents Award.

- A phase IV training event will be planned for 2013.
- The PEAC discussed the need to provide more feedback to plants regarding the outcome of their phase III completion report review.
- The Rocky Mountain Alliance was discussed. On-site plant assessments will be conducted on a voluntary basis.
- Champlain Water District is working with HACH to evaluate the possibility of incorporating features in their data analysis software that may be useful to Partnership members.

## Treatment Plant Optimization Program

### New Partnership *Presidents Award*

The Partnership for Safe Water Steering Committee is happy to announce the creation of a new award. The *Presidents Award* recognizes the Directors award plants which have been tenaciously pursuing optimization as demonstrated by meeting the Phase IV individual filter performance goals.

To qualify for this prestigious award treatment plants must:

- 1) Be in "good standing" and be a current Directors award recipient.
- 2) Have maintained monthly individual filter turbidity less than 0.10 NTU 95 percent of the time (based on values recorded at 15 minute intervals) for the past 12-months (ending no more than two months from the application date).

Have indicated intent to continue to make improvements, using a collaborative team approach, to attain fully optimized plant performance and achieve the "*Excellence in Water Treatment*" award.

It takes considerable time and effort to meet the Phase IV individual filter turbidity goals. The Partnership wants to recognize this outstanding achievement with its *Presidents Award*. We hope this will help you and your staff as you continue address action plans, move toward fully optimized treatment plant operation, and ultimately qualify for the *Excellence in Water Treatment* award.

## Distribution System Optimization Program

The Partnership's PEAC-D volunteers have started to work on the development of a "working draft" checklist of the requirements for a self-assessment completion report. This committee is also reviewing some of the tools that have been developed to assist systems in the preparation of their report. Seven selected distribution systems are piloting the self-assessment process in collaboration with the PEAC-D. This group is working through each chapter of the Self-Assessment Guide together. Feedback from the pilot process will be used to improve the Guide and other preliminary self-assessment tools.

Summaries of the self-assessment pilot process monthly meetings will be posted on the Partnership distribution system program webpage. ## Baseline Disinfectant Residual Data is Due Now

Each distribution system should submit 12-months of disinfectant residual data that will be the baseline for their performance improvement program. Use the Disinfectant Residual Data Collection software (the most current version is 1.3).

The program contains a "save file for AWWA" button that creates a copy of the summary table that can then be e-mailed to Tom at [partnership@awwa.org](mailto:partnership@awwa.org). This data is due now. Contact Tom Schippert if you have any questions.

## Policy for Compliance With Distribution System Regulations Approved

At its April 23<sup>rd</sup> meeting the Steering Committee approved policy #3 Compliance with Distribution System Regulations. This policy describes the requirements and consequences for participating utilities that received regulatory violations. The following excerpt is from policy #3:

### Policy

*Participating distribution systems shall attain compliance with applicable regulations. Specifically, systems shall be in compliance with all health-based drinking water regulations that directly apply to distribution system operations.*

### Approach

*The scale and complexity of drinking water distribution systems enhance situations that may result in regulation infractions. The Partnership for Safe Water wants distribution system operators to use the optimization tools to assess violation causes and to develop operational improvements to prevent violation re-occurrence. Therefore, it is counterproductive to suspend systems from the program upon receiving a notice of violation of a health-based regulation.*

*Systems that violate health-based regulations, but are fully committed towards making necessary improvements, will enter a two-year (starting the month following the violation) targeted optimization program that relies on water system personnel's use of the Partnership self-assessment process to evaluate the cause and determine an action plan to prevent a re-occurrence. Validated repeat violations following the execution of the action plan will generally result in suspension from the Partnership."*

### Participate in the Distribution System Optimization Program

The Distribution System Optimization Program has a total of 123 participating systems as of July 2, 2012. All size systems are represented from serving a few thousand to multi-millions. You can join this unique effort to improve the delivery of drinking water by optimizing system operations. The Partnership provides guidance and tools for systems to conduct voluntary self-assessment of the distribution system operation.

The process identifies areas for improvement and prioritizes performance improvement factors that should provide the greatest benefit. Awards are provided for reaching various levels of optimization. Recognition from the Partnership for Safe Water signifies that system operators are committed to excellence.
